<b>Tariff number I</b>	
For charging the costs of:	
- the fourth (4) and every subsequent attempt at sitting for an exam	100 points
- sitting for an exam - for persons without status	100 points
- a committee exam	200 points
- a committee exam (without status)	250 points
- bridging examination for 1 <sup>st</sup> -cycle studies	100 points
- bridging examination for 2 <sup>nd</sup> -cycle studies	300 points
- bridging examination for 3 <sup>rd</sup> -cycle studies	500 points
- the test of specific aptitudes, abilities and skills - for enrolment in study programmes in Fine Art Education, Music Education, Sports Coaching, and Architecture	120 points
<b>Tariff number II</b>	
For charging the costs of:	
- a Slovene or foreign language exam including a certificate	300 points
- a foreign language exam for postgraduate students	200 points
- an internal exam in the English or German language for candidates who do not demonstrate the English/German language proficiency at level B2	160 points
- competitive examination for enrolment in postgraduate studies	750 points
- a Slovene language exam for foreign nationals at an intermediate level - including a certificate, for enrolment in the UM	320 points
- a Slovene language exam for foreign nationals at proficiency level C2 - including a certificate, for enrolment in the UM	320 points
- other specific exams	150 points

For charging the costs of missing study obligations for:	
- course implementation including the examination within the 1 <sup>st</sup> study group - under the 1 <sup>st</sup> - or 2 <sup>nd</sup> -cycle study programme	800 points
- course implementation including the examination within the 2 <sup>nd</sup> study group - under the 1 <sup>st</sup> - or 2 <sup>nd</sup> -cycle study programme	900 points
- course implementation including the examination within the 3 <sup>rd</sup> study group - under the 1 <sup>st</sup> - or 2 <sup>nd</sup> -cycle study programme	1,000 points
- course implementation including the examination within the 4 <sup>th</sup> study group - under the 1 <sup>st</sup> - or 2 <sup>nd</sup> -cycle study programme	1,100 points

For charging the costs of the procedure for the appointment to the title of higher education teacher, researcher and faculty assistant:	
- first appointment to the title of higher education teacher	6,000 points
- re-appointment to the title of higher education teacher	4,650 points
- appointment to the title of faculty assistant and to other titles	3,650 points
<b>Tariff number VI</b>	
- costs of expert opinion on the equivalence of a professional or academic title - (diploma of professional/academic higher education, research master's degree/specialisation following academic higher education, doctorate)	1,000 points
- additional examination	800 points
- costs of the procedure for the assessment and recognition of knowledge and skills prior to enrolment or during studies	500 points
- verification or assessment of products and services	650 points
- contribution for the preparation and defence of a diploma and master's thesis for persons without status (for full- and part-time studies)	250 points
<b>Tariff number VII</b>	
For charging the costs of expert rapporteurs in the procedure for the appointment to the title higher education teacher, researcher and faculty assistant:	
- first appointment to the title of higher education teacher	1,000 points
- re-appointment to the title of higher education teacher	800 points
- appointment to the title of faculty assistant and to other titles	200 points
