In this additional application period, Slovenians without Slovenian citizenship and foreign nationals — citizens of non-EU Member States may also apply if the faculty makes that decision; however, as per priority order, enrolment places will be first filled by citizens of the Republic of Slovenia and other EU Member States, followed by Slovenians without Slovenian citizenship and citizens of non-EU Member States — foreigners. Information on enrolment places offered in the additional application period and whether these places are also available to Slovenians without Slovenian citizenship and citizens of non-EU Member States — foreigners will be posted on the my.UM website on 22 September 2025.
