Prior to the beginning of the selection procedure (by a deadline determined by the Faculty), all candidates applying for the following 2nd-cycle (master's) study programmes shall demonstrate the Slovene language proficiency at level B1 in accordance with the Common European Framework of Reference for Languages (CEFR):

- **Hungarian Language and Literature, double-major teacher-training study option in Hungarian Language and Literature,**
- **Sociology, double-major study option in Sociology,**
- **Sociology, single-major study option in Sociology,**
- **Translation and Interpreting.**

Language proficiency at level B1 prior to enrolment in the second year:

Prior to enrolment in the second year of study, all candidates applying for the following 2nd-cycle (master's) study programmes shall demonstrate the Slovene language proficiency at level B1 in accordance with the Common European Framework of Reference for Languages (CEFR):

- **Hungarian Language and Literature, double-major study option in Hungarology.**

Appropriate certificates proving the required proficiency are:

- a) the Slovene language examination certificate at level B1 or an equivalent certificate;
- b) fulfilled obligations from the *Slovene Language Development for Foreigners 1* or *Slovene as a Second and Foreign Language 1* and *Slovene Language Development for Foreigners 2* or *Slovene as a Second and Foreign Language 2* courses at the Faculty of Arts of the University of Maribor;
- c) the final certificate of primary education in RS or foreign primary education with Slovene as the language of teaching;
- d) a matura certificate or the final year certificate of a vocational secondary education programme showing the candidate has passed the Slovene language course;
- e) a certificate of completed bilingual (Slovene and a foreign language) secondary education or completed foreign secondary education with Slovene as the language of teaching;
- f) a diploma from a higher education institution in RS and a certificate (statement) that the candidate has completed the programme in Slovene.

Language proficiency at level B2 upon enrolment:

Prior to the beginning of the selection procedure (by a deadline determined by the Faculty), all candidates applying for the following 2nd-cycle study programmes shall demonstrate the Slovene language proficiency at level C1 in accordance with the Common European Framework of Reference for Languages (CEFR):

- **Slovene Language and Literature, single-major teacher-training study option in Slovene Language and Literature,**
- **Slovene Language and Literature, double-major teacher-training study option in Slovene Language and Literature**
- **Slovene Language and Literature, double-major study option in Slovene Language and Literature.**

Appropriate certificates proving the required proficiency are a matura certificate or the final year certificate of a vocational secondary education programme showing the candidate has passed the Slovene language course, the Slovene language examination certificate at level C1, or another equivalent certificate.

Language proficiency at level C2 upon enrolment:

Prior to the beginning of the selection procedure (by a deadline determined by the Faculty), all candidates applying for the 2nd-cycle study programme in **Psychology** shall demonstrate the Slovene language proficiency at level C2 in accordance with the Common European Framework of Reference for Languages (CEFR). **Appropriate certificates** proving the required proficiency are a matura certificate or the final year certificate of a vocational secondary education programme showing the candidate has passed the Slovene language course, the Slovene language examination certificate at level C2, or another equivalent certificate

Prior to enrolment, candidates shall pass the following courses corresponding to 12 ECTS credits under the 1st-cycle (bachelor's) study programme, a supplementary study programme, or by taking bridging exams: *Slovene Modern, Expressionism and Social Realism* (3 ECTS), *Slovene Literature After the Year 1950* (3 ECTS), *Phonetics and Phonology* (3 ECTS), and *Morphology* (3 ECTS).
3. An undergraduate academic study programme adopted prior to 11 June 2004 in the field of literature and linguistics – literature and a mother tongue or the first language (0232).
Candidates are typically awarded 60 ECTS credits and may enrol in the second year of study provided they satisfy the transfer criteria laid down in the accredited study programme.

Candidates are typically awarded 40 ECTS credits and may enrol in the corresponding year of study.

Selection criteria in the event of limited enrolment:

- If the number of applications exceeds the number of available enrolment places, candidates shall be ranked according to:
- grade point average (70%) and
 - grade awarded for the thesis (30%).

If the thesis is not required for completion of the study programme, only the grade point average shall be considered (100%).

Transfer criteria:

Candidates may transfer to the study programme in accordance with Articles 2 and 3 of the Criteria for Transferring Between Study Programmes (Official Gazette of the Republic of Slovenia, no. 14/19). If candidates fulfil the access requirements of the study programme and criteria for the transfer, the year of study they are to be enrolled in and study obligations required for completion of the new study programme are laid down.

Candidates may transfer to the study programme provided they fulfil the following criteria:

- they are transferring from a study programme leading to the acquisition of comparable competences or learning outcomes;
- at least half of the study obligations evaluated according to ECTS credit system of the previous study programme relating to compulsory courses of the new study programme are recognised.

Mode of study: full-time

Candidates are allowed to combine the double-major teacher-training option of the study programme in Slovene Language and Literature with a double-major study programme or double-major study option of another study programme that is not teacher-training. In this case, the student earns 15 ECTS credits more than envisaged in the study programme, since at least 60 ECTS credits shall be awarded for contents in the field of teacher training, psychology, and didactics.
