- first appointment to the title of higher education teacher	6000 points
- re-appointment to the title of higher education teacher	4650 points
- appointment to the title of faculty assistant and to other titles	3650 points
Tariff number VI	
For charging the costs of:	
- costs of the procedure for the assessment and recognition of knowledge and skills	500 points
- verification or assessment of products and services	650 points
- contribution for a thesis topic application of 1 st and 2 nd -cycle study programmes for persons without status (for full- and part-time studies)	250 points
